

SURPLUS and POSTING

As May approaches, take time to review the surplus and posting process in the Memorandum of Agreement. Any employee who was declared surplus after the start of the school year and has remained in their chosen assignment without posting out, can declare themselves surplus for next September. A similar provision exists for folks who posted in Postings #1 - #5 last year and did not have a 25-day trial period. For surplus declaration, you must notify the employer before the end of April.

OTIP OF THE MONTH: What life changes do I need to tell my auto and home insurer about?

Got a new job, moved into a new home or sold your car? Your insurance broker may not be the first person you think to discuss your life changes with, but in certain cases it's important to notify them as soon as possible. Many life changes can impact your insurance premiums. In some cases, a failure to notify your insurance broker within the time period indicated on your policy could result in one of several penalties, including your insurer's decision not to renew your policy.

Field Trip Tips and Reminders

If you are asked to go on a field trip to support a student or assist a class, ask questions ahead of time and please remember to:

- Ask ahead of time for pre-approval for pay or lieu time for additional hours, if the field trip is scheduled to go beyond your regular hours of work
- For overnight trips, every hour spent away from the worker's home on the trip, is a payable hour.
- Take your breaks and lunches
- Ensure that there is proper equipment available (change table that is not for infants, a lift if necessary, sufficient staff to support students with behaviours, etc.)
- Have access to clean water within the changing area
- Ensure that there is enough space in the washroom/change facilities
